Was a great success this year. Everyone seemed to enjoy themselves. Plenty of food and crabs. Great people, what more could you ask for?



I OPENING REMARKS/REVIEW OF MINUTES/APPROVAL:

OPENING: Bob opened the Meeting at 7:31 pm.

REVIEW OF MINUTES: Andy said the 8/13/13 Board Meeting Minutes were e-mailed to all the Board Members. He said he received one comment which he revised. "Motion made to approve the 8/13/13 Board Meeting Minutes as revised." Motion passed 7-0-0.

II <u>OLD BUSINESS:</u>

EXTRA SECURITY CONTRACT: Bob gave Andy the signed Extra Security Contract, and said there is a new provision that the Sheriff's Office has to bill CPOA before the end of the fiscal year.

III OFFICER/COMMITTEE REPORTS:

1st Vice President: CONSTRUCTION REVIEW COMMITTEE: Jim said he reviewed a request for a house on an irregular shaped lot Monroe Manor on a curve on the road. He said the proposed house will be 80 feet off the roadway and there are homes behind it on either side. Jim said the plan meets all County requirements.

2nd Vice President: POOL: Court said the Pool will close after the Crabfeast. She said she received a request from an owner on Kimberly Way to place deck boards on the old bridge at the pump house. Bob said we need to see a plan for the Board to decide. She also said the ditch under it is overgrown and needs to be cut. Bob said he would find out who owns the ditch and bridge.

Treasurer: Meg handed out Financial Statements ending 8/31/13. She said she is waiting on getting information on the see-saw replacement. Meg also informed the Board that she will no longer be able to provide Treasurer duties and said she would like to take a year off and maybe come back as a Member-At-Large. The Board thanked Meg for her hard work.

Financial Recorder: Lisa not present, no report. Bob said Lisa has agreed to continue as Financial Recorder.

Corresponding Secretary: Cindy said that the Crabfeast and Crime Watch info is on the website. She said there have no hits on the Crime Watch call for volunteers. Cindy said she has been getting requests for due payments, and has been referring them to Lisa.

Member-At-Large I: Russ not present, no report.

Member-At-Large II: Beth not present, no report.

Member-At-Large III: BEACH: Jay said he will remove the Nettle Net in the next few weeks, weather permitting. He also said he has been getting promises to hook up the security cameras, but they don't show up to do the work. The Board said a proposal from a private contractor is needed.

Member-At-Large IV: MARINA: Kevin said he is going to re-vamp the boat ramp/trailer sticker system to cut down on fraud. He believes people are buying replacement stickers for \$5 and giving them away. He also mentioned that he has plywood and insulation for the shed. A property owner complained that the shed is an eyesore. Jay responded that it was temporary and will be removed once the new Clubhouse is built.

IV NEW BUSINESS

FOUR SEASONS: Patrick McNeally gave a presentation to the Board on the revised plan for the Hovnanian's Four Seasons development at Castle Marina Road. II OLD BUSINESS:

NOISE COMPLAINT: Sgt. Johnson said he attended the Board Meeting to discuss the noise complaint regarding a dirt bike in Cloverfields. Duke said there is no noise ordinance in Queen Anne's County. He said he wrote a request many years ago for such an ordinance, but the County did not act on it. Sgt. Johnson said that there is a State law on noise enforced by the Maryland Department of the Environment (MDE). Bob said he spoke with the owner and asked her to come to the Board Meeting to discuss with the Sheriff's deputies. Sgt. Johnson said he will visit the dirt bike owner and the owner who complained to try to get a dialog started between them. He also said that if the dirt bike owner does not cooperate, then MDE should be called and they will meter the noise to see if it is within the law limits. He read the a copy of the COMAR 26.02.03.02 Environmental Noise Standards.

CRIME WATCH: Lt. Heddinger said there were 3 incidents in Cloverfields over the last month that generated reports. He said there was a vehicle accident on Old Love Point Road and Larch today. Sgt. Johnson said he caught some non-resident youth on the Beach and sent them away. He said other than these minor incidents, Cloverfields is a very safe community with little crime activity. Andy said he heard that a woman's car got egged on his street, and Courtney said she heard more cars were egged.

CRABFEAST: Bob said he is working on contracting the crabs, and said he will get the gambling and alcohol permits. Bob said that Farmer John said he will donate the corn.

GENERAL MEMBERSHIP MEETING: Bob reminded the Board that the General Membership Meeting is scheduled for 9/15/13 at 2:00 pm, the day after the Crabfeast.

III OFFICER/COMMITTEE REPORTS:

- 1st Vice President: CONSTRUCTION REVIEW COMMITTEE: Jim said he invited an owner to the meeting who is asking for a fence variance. The owner showed pictures of her situation with her neighbors on her PC. She asked to erect a fence against a fence, and to erect a fence beyond the front corner of her house along her driveway. December Is Safe Toys and Gifts Month

It's almost gift-buying season, and with so many toys on the market, it's more important than ever to be sure you're buying safe toys for children. Toy-related injuries send tens of thousands of children to the emergency room each year.

Here are some tips for buying safe toys:

- Don't give toys with small parts to toddlers and small children.
- Select toys to suit a child's age, abilities, skills, and interest level.
- Look for the letters "ASTM," indicating that a product meets national safety standards.
- Avoid toys with electric heating elements.

Instructions for Cooking a Turkey

Prep time: 15 minutes **INGREDIENTS**

• 1 turkey, approx. 15 lbs.*

• Juice of a lemon
• Salt and pepper
• Olive oil or melted butter
• 1/2 yellow onion, peeled and quartered
• lops and bottoms of a bunch of celery
• Zarrots
• Parsley
• Sprigs of fresh rosemary, thyme

12-15 lb turkey for 10-12 people

15-18 lb turkey for 14-16 people 18-22 lb turkey for 20-22 people

METHOD

1 To start, if the turkey has been refrigerated, bring it to room temperature before cooking. Keep it in its plastic wrapping until you are ready to cook it. While in the refrigerator, and or while you are bringing it to room temp, have the bird resting in a pan, so that if the plastic covering leaks for any reason, you are confining the juices to the pan. If you get a frozen turkey, you will need to defrost it in the refrigerator for several days first. Allow approximately 5 hours of defrosting for every pound. So, if you have a 15 pound turkey, it will take about 75 hours to defrost it in the refrigerator, or around 3 days. Handle a raw turkey with the same amount of caution as when you handle raw chicken - use a separate cutting board and utensils to avoid contaminating other foods. Wash your hands with soap before touching anything else in the kitchen. Use paper towels to clean up. Remove the neck and giblets (heart, gizzard, liver). Use the heart and gizzard for making stock for the stuffing. The neck can be cooked along side the turkey or saved for turkey soup. Note that if your turkey comes with a plastic piece holding the legs together, check the instructions on the turkey's package. Most likely you do not need to remove those plastic ties for cooking (unless you plan to cook your turkey at a very high temperature). If you remove the plastic ties, you will need to use kitchen string to tie the legs together.

- **2** Preheat the oven to 400 degrees F.
- 3 Wash out the turkey with water. Pull out any remaining feather stubs in the turkey skin. Pat the turkey dry with paper towels. Lather the inside of the cavity with the juice of half a lemon. Take a small handful of salt and rub all over the inside of the turkey.
- 4 In this method of cooking a turkey, we don't make the stuffing in the turkey because doing so adds too much to the cooking time. For flavor, put in inside the turkey a half a yellow onion, peeled and quartered, a bunch of parsley, a couple of carrots, and some tops and bottoms of celery. You may need to cap the body cavity with some aluminum foil so that the stuffing doesn't easily fall out. Close up the turkey cavity with either string (not nylon string!) or metal skewers. Make sure that the turkey's legs are tied together, held close to the body, and tie a string around the turkey body to hold the wings in close. The neck cavity can be stuffed with parsley and tied closed with thin skewers and strina.
- 5 Rub either melted butter or olive oil all over the outside of the turkey. Sprinkle salt generously all over the outside of the turkey (or have had it soaking in salt-water brine before starting this process). Sprinkle pepper over the turkey.
- 6 Place turkey BREAST DOWN on the bottom of a rack over a sturdy roasting pan big enough to catch all the drippings. This is the main difference between the way mom makes turkey and everyone else. Cooking the turkey breast down means the skin over the breast will not get so brown. However, all of the juices from the cooking turkey will fall down into the breast while cooking. And the resulting bird will have the most succulent turkey breast imaginable. Add several sprigs of fresh (if possible) thyme and rosemary to the outside of the turkey.
- 7 Chop up the turkey giblets (gizzard, heart). Put into a small saucepan, cover with water, add salt. Bring to simmer for an hour or so to help make stock for the stuffing.
- 8 Put the turkey in the oven. Check the cooking directions on the turkey packaging. Gourmet turkeys often don't take as long to cook. With the turkeys mom gets, she recommends cooking time of about 15 minutes for every pound. For the 15 lb turkey, start the cooking at 400 F for the first 1/2 hour. Then reduce the heat to 350 F for the next 2 hours. Then reduce the heat further to 225 F for the next hour to hour and a half. If you want the breast to be browned as well, you can turn the bird over so that the breast is on top, and put it in a 500°F oven or under the broiler for 4-5 minutes, just enough to brown the breast. Note that if you do this, you will have a higher risk of overcooking the turkey breast. Start taking temperature readings with a meat thermometer, inserted deep into the thickest part of the turkey breast and thigh, an hour before the turkey should be done. You want a resulting temperature of 175°F for the dark meat (thighs and legs) and 165°F for the white meat (breast). If you don't have a meat thermometer, spear the breast with a knife. The turkey juices should be clear, not

NOVEMBER IS AMERICAN DIABETES MONTH


Type 2 diabetes used to be known as adult-onset diabeters, but unfortunately, the disease isn't limited to adults anymore. With child obesity rates climbing, diabetes is becoming more prevalent in children as well.
