I OPENING REMARKS/REVIEW OF MINUTES/APPROVAL:

OPENING: Bob opened the Meeting at 7:32 pm.

REVIEW OF MINUTES: Andy said that he e-mailed the 7/14/15 Board Meeting Minutes to all Board Members and said he received no comments. Motion made to approve the 7/14/15 Board Meeting Minutes as written. Motion passed 7-0-0. - I. INTRODUCTION: Bob opened the Meeting at 2:03 pm. Bob thanked everyone for attending and introduced the Board Members.
- II. REVIEW OF MINUTES: Andy read the draft minutes from General Meeting of 9/21/14 that was available to the General Membership as a handout. He read them and asked if there were any comments or corrections to the Minutes, and there were none. "Motion made to approve 9/21/14 Minutes as written." Motion passed 15-0-0.
- III. OLD BUSINESS:

CLUBHOUSE: Fred said the new Clubhouse is nearing completion and thanked all the volunteers who helped with the various tasks.

CLEAN UP DAY: Bob thanked all the volunteers who helped with Clean Up Day at the Beach, Playground and Clubhouse.

SECURITY CAMERAS: An owner asked about the status of the security cameras and Bob said 15 cameras have been purchased and they will be installed at the Beach, Marina, Pool and Clubhouse. He said the cabling is being run to the Clubhouse, and once it is opened, the DVD recorder will be housed there.
- IV. OFFICER/COMMITTEE REPORTS:
 1. 1st Vice President: CONSTRUCTION REVIEW: Jim said he is up to date on CR requests.
 2. 2nd Vice President: POOL: Courtney said she is getting the Pool ready for the season, and that Bay Area has been hired as the maintenance contractor. She said Pool will open on May 22. WOMEN'S ASSOCIATION: Court said the Easter Egg Hunt went well and thanked the bunny for volunteering.
 3. Treasurer: Jeanette said the Financial Statements ending on March 31, 2015 were available as a handout. She said all the bills have been paid to date.
 4. Financial Recorder: Lisa not present, no report. Bob said 82% of owners have paid their dues so far.
 5. Corresponding Secretary: Cindy said that the Cloverfields website is going well, and informed all what information can be placed on the site.
 6. Member-At-Large I: CRIME WATCH: Russ said some mailboxes were knocked over and that an owner had their SUV window busted out.
 7. Member-At-Large II: Grant thanked all the volunteers who helped with the Playground during Clean Up Day. He said 22 cubic yards of woodchips were spread. He said next year they may need more.

 10. Recording Secretary: CLUBHOUSE: Andy present, no report.
- V. NEW BUSINESS:

DRAINAGE PROBLEM: An owner spoke about a drainage problem in a ditch at Petinot which is filling with silt from Monroe Manor. Bob said this a County issue and said he will call them to take a look.

POOL PASSES AT BEACH: An owner asked about controlling transients at the Beach and Bob said there will be a new policy that people without vehicle stickers at the Beach will need to have their Pool Passes with them and will need to prove that non-resident guests are with them. This will be enforced by the Gateguards who are on duty during the weekends.

BEACH PARTY: Bob said the Beach Party this year will be on July 4th starting at 2:00 pm. He said CPOA will supply burgers, hot dogs, fixings, drinks and materials. Owners will be asked to bring a side dish and guests will need to pay \$3.00 fee. He said all owners will need to bring their Pool Passes for attendance.

POT HOLES: An owner asked about how to get pot holes on Nichols Manor repaired, and Bob said to call the County.

BEACH PARKING LOT: Bob said millings will be added to the Beach Parking Lot.

Cloverfields Clubhouse Update

The new Cloverfields Clubhouse is now available for rentals.

The banquet hall is about 1800 square feet, with standard-height tables and chairs for 80, and bar-height table and chairs for 12 included in the rental fee. There is an 800 square foot kitchen, with both a 3 compartment sink and a prep sink. A large stainless steel prep table in the middle of the kitchen for set up and food prep. The cooking appliances include a 6 burner stove plus a 24" griddle top, and 2 ovens, a 36" char-broiler and a 16 lb. gas fryer. All of the cooking appliances are under a large exhaust hood with a commercial-grade fire suppression system. We have an ice machine with an 800 lb. bin for your use.

The rental rates are:

- \$200.00 for a half day (up to 6 hours including setup and cleanup, for small parties under 50 people), and
- \$400.00 for a full day (large parties such as wedding receptions, family reunions, etc.).
- There is also an optional \$50.00 surcharge for the use of the cooking appliances, and
- A required \$100.00 deposit for cleanup and damage which is refunded after the event if all is well. Rentals can only be booked by Cloverfields Community members with dues in good standing.


