#### OPENING REMARKS/REVIEW OF MINUTES/APPROVAL:

OPENING: Bob opened the Meeting at 7:37 pm.

REVIEW OF MINUTES: Andy said he e-mailed the 9/13/16 Board Meeting Minutes and said he received one revision comment, which he revised. Motion made to approve the 9/13/16 Board Meeting Minutes as revised. Motion passed 6-0-0.

#### II OLD BUSINESS:

CRIME WATCH: There was no representative from the QA Sheriff's Dept. at the meeting, but Bob had the Sheriff's Calls for Service for the last 30 days. There were 33 Calls in the local area with 4 Reports generated in Cloverfields, nothing major. 1<sup>st</sup> Sgt. Bowser of the MTA Police informed the Board that the Bridge Police have a new boss, Lt. Jason Pullian. Sgt. Bowser mentioned that there will be a Bay Bridge Walk/Run on November 6. He said the eastbound Bay Bridge will be closed from 4 am to about 2 pm. He said there was a Bridge jumper last evening. Bob asked him where one goes to Court if you get a ticket on the Bridge and he said either Annapolis or Centreville - depends on which side of the County line on the Bridge the infraction occurs.

EXTRA SECURITY: Bob said he signed up for Extra Security patrols for Halloween.

CRAB FEAST: Bob said the Crab Feast went well with very good crabs. He thanked the volunteers who helped set it up and cleaned up.

MARINA WALL: Bob said the Marina wall will be replaced in November/December. He said the channel leading into the River will be closed approximately 10 days during construction.

NEWSLETTER: Bob said to get articles to Kathy for the next Newsletter ASAP.

NETTLE NET: Bob said the plan is to remove the Nettle Net from the River this weekend.

#### III OFFICER/COMMITTEE REPORTS:

1<sup>st</sup> Vice President: CONSTRUCTION REVIEW: Jim said he spoke to a property owner at Monroe Manor who wants to connect his proposed fence to the front corner of his house. Jim informed him he needs a variance from the Board and asked him to attend a Board Meeting to plead his case.

2nd Vice President: POOL: Court said the Pool cover has been ordered. Bob said he found some funds in the Budget to cover the cost. He said some of the tile and concrete step work can also be done with some remaining Budget funds. Court passed around the table 2 proposals itemizing the repair work with their costs. The Board asked her to figure out the best way to proceed and to check with Bob to make sure the funds are available. Court also mentioned that she has 2 proposals so far for Pool maintenance contract for next season. WOMEN'S ASSOCIATION: Court said the Halloween parade is scheduled for 10/30 beginning at the Playground. She said signs will go up in the neighborhood.

Treasurer: Jeanette not present, no Financial Statements available.

Financial Recorder: Cindy said she continues working on potential electronic due payments. She started a QuickBooks trial. She said there is a 50 cents per transaction fee for bank transfers. She said credit card payments may be more. Cindy said she needs all of the invoice statement records in order for her to set up the QuickBooks system. She would like the paper invoice to have an option to go on line to pay electronically via QuickBooks.

Corresponding Secretary: Vacant.

Member-At-Large I: CRIME WATCH: Russ said he had no calls for Crime Watch.

Member-At-Large II: PLAYGROUND: Grant said he will set up the Playground border replacement and mulching project in the spring.

Member-At-Large III: BEACH: Jay not present, no report.

Member-At-Large IV: Vacant.

Recording Secretary: CLUBHOUSE: Andy said he has been replacing the burnt Clubhouse light bulbs with LED light bulbs.
