
POOL RULES

* NO POOL PHOTO I.D. – NO ENTRY *

NO PETS OR GLASS

- 1. Pool Hours: 10 A.M. to 8 P.M. Monday through Saturday and 12:00 Noon through 8 P.M. Sunday
- 2. Guest Policy: \$3.00 per person per day. Guests will be limited during high occupancy (80% of pool capacity)
- 3. All children 10 years or younger must have an adult, 18 year or older in attendance who is required to stay in the pool area with the child. All children 11 years or older are allowed in the pool by themselves (must pass a swim test)
- 4. The baby pool is reserved for children under the age of 6. All children must have an adult in attendance at all times in the baby pool area. Babies and children not toilet trained must wear disposable diapers with rubber pants over them to swim in the baby or main pool.
- 5. Adult swim is 15 minutes before every hour. 18 years and older.
- 6. No running, rough playing in the pool area, or diving in the shallow end where marked.
- 7. No cut offs, no street clothes in pool.
- 8. Lifeguard may require you to pass a swim test for deep end swimming.
- 9. Please clean up after yourselves.
- 10. CPOA is not responsible for any injuries or theft, and reserves the right to close the pool at any time.
- 11. You will be asked to leave if you fail to comply will any and all of the rules.

April 11, 2017 7:30 pm MEETING MINUTES

I OPENING REMARKS/REVIEW OF MINUTES/APPROVAL:

OPENING: Bob opened the Meeting at 7:33 pm.

REVIEW OF MINUTES: Andy said he e-mailed the draft 3/14/17 Board Meetings and said he received no comments. Motion made to approve the 3/14/17 Board Meeting Minutes as written. Motion passed 5-0-0.

II OLD BUSINESS:

CRIME WATCH: Sgt. Davidson handed out the Calls for Service for the period of 3/4/17 to 4/4/17, and said there were 29 calls for service in the local area, which generated 10 reports, 8 in Cloverfields for animal complaints, a recovered property and a missing person. He also handed out a report of thefts from motor vehicles for the last 2and a half months showing 67 thefts in Stevensville, 15 in Cloverfields. The most were from Bay City with 21. Sgt. Bowser said Bay Bridge is gearing up for the summer season traffic by suspending Friday night closures. He also mentioned that Bridge jumpers have picked up.

CALMING HUMPS: Two Community Members asked the Board if it is possible to install calming humps in Cloverfields due to excessive speeders on Larch. They said most of the speeding is in the morning between 6 and 8 am. Bob said the past County Commissioners did not support calming humps. He said this request will need to be approved by the County and the new Commissioners. Bob said he will contact all the major personnel for guidance.

GENERAL MEETING: Bob said the General Meeting went well.

MARINA: Bob said the work on the Marina wall is nearing completion, with the barge leaving the channel tomorrow.

PROPERTY SURVEY: The owner of a property that had a dispute with her neighbor about a property line for a fence said the situation continues with more surveying and a cease and desist order.

III OFFICER/COMMITTEE REPORTS:

1st Vice President: CONSTRUCTION REVIEW: Jim said CRC requests have picked up and he is

working on them.

2nd Vice President: POOL: Courtney was out of town, no report. Bob said the Pool cover is coming off soon. Two CPOA Members said they have raised \$410 so far on the web for the umbrella fundraiser. They asked the Board if heavier trash cans can be purchased with good lids to keep the flies down and from blowing trash. Bob said this needs to be discussed with Courtney. They also asked if they can organize a movie night in the Clubhouse once the TV is ready for use. The Board informed them that they need to come to the Board and get approval if they want to organize any activities in the Clubhouse.

Treasurer: Jeanette said the bills are all paid.

Financial Recorder: Cindy said the dues are slowing down.

Corresponding Secretary: Vacant.

Member-At-Large I: CRIME WATCH: Russ said everyone needs to lock up their homes, cars, sheds and whatever they can to keep their stuff safe.

Member-At-Large II: PLAYGROUND: Grant not present. Grant e-mailed the Board Members that he resigned from the Board due to the building of his new home. The Board said they appreciated all of his work with the Board.

Member-At-Large III: BEACH: Jay not present, no report.

Member-At-Large IV: Vacant.

Recording Secretary: CLUBHOUSE: Andy said the LED lights have been installed in the Clubhouse.

IV NEW BUSINESS:

EAGLE SCOUT: An Eagle Scout candidate from Troop 278 asked the Board if could replace the sign at the Beach/Marina as his Eagle Scout project. He said he would install a new sign with the Board's required information. Bob asked him to send all of the plans to the Board for approval.

FLAGPOLE: The Board thanked Craig Patterson and Ken Meinhardt for fixing the Marina flagpole.

MARINA VOLUNTEERS: The Board thanked the following volunteers for helping at the Marina: Jack Sheehan for repairing the electric problems; Kevin Finney for fixing the light sensor; Bo Otto for making the Tide Marker; and Steven Trumpler for all his help in getting this work permitted and completed.

4TH OF JULY PARTY: The Board agreed to host the Beach Party on Saturday, July 8, with the same setup as last year. CPOA Members need to bring their Pool Passes to get in, and guests of CPOA Members are \$3.00. Please bring a dish to share.

NEWSLETTER: Items for Kathy for the next Newsletter are due soon.

PLAYGROUND: Bob said he will ask the marine contractor working on the Marina for a price to remove the old border timbers from the Playground.

Meeting adjourned at 8:34 pm.
