

Cloverfields HOA COMMITTEES

"Below is a list of the current neighborhood committees in Cloverfields. If you are interested in helping on any of the committees, visit the Contact Us webpage on www.cloverfields.org to submit a note of interest."

- The Youth Activities Committee shall have the responsibility for the development, supervision and operation of youth activities.
- The Boat Basin Committee shall have the responsibility for supervision, operation and maintenance of the boat basin, ramp and inlet.
- The Clubhouse Committee shall have the responsibility for supervision, operation and maintenance of the clubhouse.
- The Community Betterment Committee shall have the responsibility for all matters affecting
 the welfare of the community (such as zoning, street signs, removal of eyesores, drainage,
 etc.)
- The Finance Committee shall prepare a budget for presentation to the Board at the August meeting and to The Association at its annual meeting for adoption.
- The Pool Committee shall have the responsibility for supervision, operation and maintenance of the pool.
- The Recreational Facilities Committee shall have the responsibility for the supervision, operation and maintenance of the facilities of The Association except for the boat basin, the beach and the pool.
- The Beach Committee shall have the responsibility for the supervision and maintenance of the beach area.
- The construction Review Committee shall have the responsibility for reviewing all site improvements and building plans in accordance with Board policy.
- The Crime Watch Committee shall have the responsibility of the organization, supervision and operation of a Crime Watch Program, within the confines of the CPOA, in conjunction with the Queen Anne's County
- Each Vice President will coordinate the activities of four standing committees as designated by the President.
- Such other committees shall be appointed by the President as The Association or the Board deem necessary.

I OPENING REMARKS/REVIEW OF MINUTES/APPROVAL:

OPENING: Bob opened the Meeting at 7:30 pm.

REVIEW OF MINUTES: Andy said he e-mailed the draft 8/7/17 Board Meeting Minutes to all Board Members and said he received 2 comments which he corrected. Motion made to approve the 8/7/17 Board Meeting Minutes as revised. Motion passed 5-0-0.

II OLD BUSINESS:

CRIME WATCH: There were no attendees from the Sheriff's Dept. present.

CRABFEAST: Bob said the Crab feast went well with over 100 in attendance. The Board thanked the following for their donations: Farmer John, Harris Crab House, Big Bats, Love Point Deli, AMJ, Kim Patchett, the Pool Snack Shack, and DJ Tommy for cranking out the tunes, and Darin and Russ for running The Wheel.

SWIM TEAM: The Swim Team Committee asked if they could have another Movie Night fundraiser on 11/3/17 in the Clubhouse and the Board approved. Cindy reminded the Chair they need to show her receipts of all of their deposits.

GENERAL MEETING: Bob reminded the Board that the next General Meeting is scheduled for 9/17/17 at 2:00 pm.

BEACH PORT-A-POT: Bob said one of the port-a-pots at the Beach has been removed.

III OFFICER/COMMITTEE REPORTS:

1st Vice President: CONSTRUCTION REVIEW: Jim not present, no report. Jim send an e-mail to Board Members informing them that his work schedule has changed where he will now be able to attend Board Meeting on a regular basis.

2nd Vice President: POOL: Courtney said the Pool is now closed and will be winterized.

Treasurer: Jeanette said that about 60 late bills with late fees will be mailed out. Bob said we are going back to 2 stickers for boat and trailer. He said trailer registrations will not be required. He also mentioned that if CPOA boaters do not get their stickers by Memorial Weekend, they will be charged more, unless you are a new home owner, or buy a new boat. He said too many procrastinators wait until summer to get their stickers, and that puts a burden on the volunteers who issue them.

Financial Recorder: Cindy said there were 5 house sales in the past month.

Corresponding Secretary: Vacant.

Recording Secretary: CLUBHOUSE: Andy said the Clubhouse experienced another overflow problem from the upstairs heat pump unit, but this time the newly-installed drain pan switch turned off the unit before the hallway flooded. He said the HVAC contractor came and fixed the plumbing problem at no charge.

IV NEW BUSINESS:

FISHING PIER: Bo Otto said the fishing pier is in bad shape and needs to be replaced. He said the old plans may be somewhere in the Clubhouse. Andy said he would look for them.

BAY BRIDGE RUN: Bob said the Bay Bridge Run is scheduled for 11/5/17.

SIDWALKS: Bob said he has received complaints about no street lights and sidewalks in Cloverfields. He said they need to contact Queen Anne's County Roads.

CLUBHOUSE RAIN GARDEN: The Board thanked Fred Sebly for cleaning up, mulching and re-planting the Clubhouse rain garden.

MARINA LIGHTS: Bob thanked James Haggerty for volunteering to repair the lights at the Marina.

SNACK SHACK: The Board thanked Meredith for running the Snack Shack this summer.

CLUBHOUSE RENTAL AGREEMENT: Bob said he will discuss revising the Clubhouse rental agreement with Kelly to add a cancellation fee and liability to the renters for damages over the \$100 deposit.

COMMITTEES: An owner spoke about the need to fill the 16 Committees with volunteers. Bob said he will ask for volunteers at the General Meeting.

Meeting adjourned at 8:12 pm.


