# **CPOA By-Laws Update**



# Below are the new by-laws that were discussed and voted on at the April 15, 2018 General Membership Meeting.

Article 5, Sections 2 and 3

Section 2. At the April Board of Directors meeting a Nominating Committee of five full members shall be elected. It shall be the duty of this committee to nominate candidates for offices to be filled at the annual meeting. Candidates must state their willingness to serve if elected. The committee shall submit the list of nominees to the Board of Directors at the August meeting for inclusion in the Call to the annual meeting. The final list of nominees must be posted on the community web site and publicized to the community at large for general awareness immediately following the aforementioned August meeting. Additional nominations for any position may be made no later than two weeks in advance of the annual meeting by presentation to the Recording Secretary of the declaration of intent to be a candidate signed by the candidate and two sponsoring full members, all in good standing, then approved by the Nominating Committee. Any additional nominations must be posted on the community web site and publicized to the community at large for general awareness no later than a week prior to the annual meeting.

Section 3. The officers shall be elected by ballot at the annual meeting of The Association. Current Board Members will be responsible for verifying voters' residential status before distributing the ballots. Each household of the community is allocated one vote. A majority vote shall elect. Current Board Members will count the ballot votes, with a non-Board Member community volunteer presiding over the ballot count to verify accuracy. In the event of three or more candidates running for an office, no one of whom receives a majority, there shall be a run off between those two candidates receiving the most votes. Should there be only one candidate for each office the Recording Secretary may be instructed by a two thirds vote to cast the ballot for The Association.

#### Article 6, Section 5

Section 5. The Corresponding Secretary shall notify board members of meetings, create community newsletter, update community web site, manage any online communications, and shall conduct such correspondence as may be requested by the President or The Association. He/she may co-sign checks.

- I. <u>INTRODUCTION:</u> Bob opened the Meeting at 2:17 pm. Bob thanked everyone for attending and asked everyone to make sure they sign in.
- II. <u>REVIEW OF MINUTES</u>: Andy read the draft minutes from General Meeting of 4/9/17 that was available to the General Membership as a handout. After reading them, he asked if there were any comments or corrections to the Minutes, and there were none. "Motion made to approve 4/9/17 Minutes as written." Motion passed 57-0-0.
- III. OLD BUSINESS: None.
- IV. <u>NEW BUDGET:</u> Bob informed the Membership that one of the handouts is the proposed 2018 Budget. He said that the Clubhouse loan has been paid off, and that a shed for the Clubhouse is included in the Budget. One owner asked why the Swim Team is not in the Budget and Courtney explained that it has been independently self-supporting since the beginning. Bob said the Swim Team raises its own funds and gives the Board income and expense reports. Bob asked for a show of hands for and against the New Budget as written. The Membership approved it unanimously.

#### V. OFFICER/COMMITTEE REPORTS:

- 1. 1st Vice President: CONSTRUCTION REVIEW: Jim said he is catching up on several CR requests.
- 2. 2nd Vice President: POOL: Courtney said the Pool is closed for the season. She said over \$5,000 in guest fees were collected, and new umbrella stands were added. SWIM TEAM: Meredith mentioned that there was no Swim Team this summer, and that a new team with new coaches is being organized for next season.

- 3. Treasurer: Jeanette said there are 64 delinquent owner dues to date.
- 4. Financial Recorder: Cindy said she still continues collecting some late dues. She said she is gearing up for the next dues collection cycle.
- 5. Corresponding Secretary: Vacant.
- 6. Member-At-Large I: CRIME WATCH: Russ said there was a hit and run incident at the Beach, and that the perpetrator has yet to be caught.
- 7. Member-At-Large II: PLAYGROUND: Vacant.
- 8. Member-At-Large III: BEACH: Jay present, no report.
- 9. Member-At-Large IV: MARINA: Vacant.
- 10. Recording Secretary: CLUBHOUSE: Andy said the heat pump air handlers in the Clubhouse have all been equipped with P-traps and pan overflow cut-off switches.

#### VI. <u>NEW BUSINESS:</u>

VACANT COMMITTEE CHAIRS: Bob said there are 16 CPOA Committees that need volunteers to chair and that need help organizing. He asked to see him for more information.

VII. <u>VOTE FOR OFFICERS:</u> Bob asked the Membership to take a ballot to vote for the following Board positions up for election:

President, 2<sup>nd</sup> Vice President, Financial Recorder, Corresponding Secretary, Member-At-Large I, Member-At-Large IV

Several Members who were on the ballot spoke about why they would like to be elected to the Board.

The ballots were collected and the vote count was witnessed by 2 volunteers from the Membership.


