CRIME WATCH: Lt. Duke mentioned that opioids are still a major problem in the County and that there were 9 unattended deaths last week. BAY BRIDGE: Cpl. Grey said that the jack-knifed truck that created the traffic mess was caused by someone making a U-turn just before the westbound bridge. SNACK SHACK: Ken Meinhardt said the new Snack Shack is 95% completed. The Board thanked Ken and Jack Sheehan for building the new Shack.

BEACH REPAIRS: Bob said the contractor who is contracted to help with the Beach erosion has been tied up on another job and is planning on coming in 2 weeks to do our job.

POOL EQUIPMENT: Bob said the Pool equipment and chairs have been stored in the bathhouse. POOL MANAGEMENT COMPANY: Bob said he and the Pool Committee are reviewing the Pool Management proposal.

SUPPER WITH SANTA: Bob mentioned that the Supper With Santa is scheduled for this Sunday.

Andy also mentioned his concern about the ice machine in the kitchen. He said the large ice storage bin is very heavy and is damaging the floor, and that only a small portion of the ice is ever used. He told Bob he will send him information on a much smaller ice maker with enough capacity to keep the Snack Shack and rentals fully stocked.
