



NEW BUSINESS

Bob reported he is getting the Newsletter out.

Budget: Bob discussed the funding for the state-mandated required reserve fund. A 35.00 dues increase should cover it. The board reviewed all the options and will put to a vote at the General membership meeting.

Crab Feast will be Sept. 6; tickets are printed up.

The General Membership meeting will be September 21; ballots printed for elections.

Pool to close September 1st. The pool plaster replacement was brought up and one quote to completely replace is 39,000. Courtney is getting another quote also.

New shower knob is needed in the bathhouse. Prices are being looked into.

The pool management contract went up.

Paulo was thanked for putting up the pool toy.

Beach: Golf carts, ATVs and vehicles have been driving on the Beach. Wooden poles are being installed in the ground to prevent this. Also adding some pilings by the boat ramp.

Marissa and Bob are still working on the Kayak racks.

The Board needs to discuss when and how to turn off the gate key passes. When a resident pays the pass is reactivated.

Trees are being removed and/or trimmed by the port-o-potty; some are mostly dead.

Dates for dues collection were decided so they can be put on the green sheet that goes out with the bill. Bob noted the price of stamps when sending out the bills. Shelved were installed in the office.

10,000 blank ID cards were ordered. Much better price when ordered in bulk. New Car/Boat stickers to ordered also.

50 households still owe dues, good for community this size.

Davol requested a road closure again this year for Halloween. Bob has contacted the County.

The new website signs have been added to the existing Cloverfields signs.


